LOCAL BROADCAST LICENSE

The terms "Broadcast Sponsor," "Program," and "Broadcast Transmission Platform," shall have the meanings as defined above in the relevant sections of this Local Broadcast License ("License").

CSPS reserves the right to deny licenses for any reason. Upon approval by CSPS of this License, Broadcast Sponsor shall have a limited non-exclusive license (this "License") to broadcast the Program on the Broadcast Transmission Platform, in accordance with the information provided by Broadcast Sponsor herein. This License shall continue until it is cancelled by Broadcast Sponsor or CSPS.

This License is subject to the following terms and conditions:

1. CSPS reserves the right to terminate, expire, or recall Programs. Either party may terminate this License on 30 days written notice.
2. Any liability of CSPS will be limited to the cost of the individual Program.
3. Programs are owned and copyrighted by CSPS and are not to be duplicated without express written permission from CSPS.
4. Programs may only be used in accordance with this License. Each Broadcast Sponsor shall use this agreement to license the Program(s) they will use and such licensed Program(s) may be used on multiple broadcast transmission platforms in accordance with this License. (For example: *Christian Science Quarterly*[®] Weekly Bible Lessons on both a radio station and a telephone line).
5. This License permits the specified Broadcast Transmission Platform(s) to perform the Program(s) in accordance with instructions from Broadcast Sponsor consistent with the terms of this License.
6. This License is specific to the Broadcast Sponsor, Program(s), and Broadcast Transmission Platform(s) as defined in this License. No license is given for Broadcast Sponsor to allow others to broadcast Programs.
7. Programs that are made available to the public via telephone call-in are considered to be broadcasts. While Programs can be licensed for telephone broadcast on toll free numbers, such broadcasts will be listed on JSH-Online under the location of the Broadcast Sponsor.

8. This License supersedes all prior licenses and agreements for use of the Programs. Except as set forth herein, no modification of this License will be effective without the express written agreement of the parties.
9. Prices are subject to change on 30 days written notice from CSPA.
10. Programs covered by this License may be included as part of an AM or FM radio Broadcast Station's streaming Internet simulcast programming, provided that the simulcast is concurrent with the radio broadcast.
11. No license is given to originate or archive Programs on the Internet or to make Programs available for downloading.
12. Programs must be performed in their entirety and may not be altered or edited.
13. Broadcast Sponsor shall abide by the Trademark Use Guidelines and General Broadcasting Guidelines set forth below, as may be amended from time to time by CSPA.
14. CSPA represents and warrants that it owns or has a license to all copyrights, trademarks, and other intellectual property rights associated with the Programs necessary for Broadcast Sponsor and Broadcast Transmission Platform to broadcast the Programs as permitted under this Agreement;
15. CSPA will indemnify, defend, and hold harmless Broadcast Sponsor and Broadcast Transmission Platform from any and all losses, damages, liabilities, costs, charges, and expenses, including reasonable attorneys' fees, arising out of: (i) any breach of CSPA's representations and warranties in this Agreement, and (ii) any claim against Broadcast Sponsor or Broadcast Transmission Platform that the content of the Programs, as delivered by CSPA and unedited by Broadcast Sponsor or Broadcast Transmission Platform, is defamatory or infringes intellectual property rights of third parties according to U.S. law.

TRADEMARK USE GUIDELINES

Christian Science Sentinel[®], *Christian Science Quarterly*[®], and *El Heraldo de la Ciencia Cristiana*[®] are registered trademarks owned by CSPA ("CSPA Trademarks"). When your Local Broadcast License has been approved by CSPA, you will have a revocable worldwide license from CSPA, during the term of this License, to use CSPA Trademarks and their accompanying logos for the sole purpose of promoting your local broadcasts of the Programs in newspaper advertisements, posters, flyers, billboards, social media, websites, or other print advertisements and for no other purpose.


- CSPA Trademarks should not be co-branded with other trademarks, meaning they should be distinct and separate from other entities' trademarks (i.e. radio station logos, branch church or local broadcasting committee names/logos, etc.).
- Any logo requests should be directed to broadcasting@cspa.com.
- Broadcast Sponsor will abide by these Trademark Use Guidelines and any other trademark use instructions as may be provided by CSPA from time to time in advertising and/or promoting the Programs.
- Broadcast Sponsor agrees that all use of CSPA Trademarks by Broadcast Sponsor will be to CSPA's benefit.

GENERAL BROADCASTING GUIDELINES

- Institutional users must have a License in the institution's name in order to play Programs on a closed system in an indoor location, such as a P.A. system at a Christian Science care facility. Permission is not given to play Programs on speakers located outside of Reading Rooms or other facilities, due to local ordinances and regulations.
- Only Programs specifically licensed for broadcast may be used for such purposes. Audio-visual products intended for sale to or subscription by the general public, or for sale or performance in Reading Rooms, are not licensed for broadcast, nor are they to be duplicated.
- As a general rule, dated Programs intended to be broadcast during a specified time period must be aired during that period. For example, weekly Programs must be aired at least once during the specified week.
- Except in extreme situations, *Weekly Bible Lesson* Programs should not be aired outside of the specified broadcast week; in such circumstances, please contact us right away.
- Dated *El Herald* Programs should be broadcast outside the specified time period ONLY if circumstances beyond the reasonable control of CSPA, Broadcast Sponsor, or Broadcast Transmission Platform prevent broadcast of a dated Program during that period.
